1.1 Mr Mewa Ramgobin former husband of Mrs Ela Gandhi and former ANC MP who passed away Monday night after a prolonged illness. The former Natal Indian Congress president and author of "Waiting to Live" and "Prisms of Light" was amongst the first supporters of the Release Mandela campaign.

He was banned for 17 years, placed under house arrest for 12 years and charged for treason in 1985 whilst he was a member of the United Democratic Front.

He was an ANC MP until 2009.

He was the founder of Centre for Learning of Ubuntu and Chairperson of Phoenix Settlement Trust, founded by Mahatma Gandhi in 1904.
