FRIDAY, 01 NOVEMBER 2019

The House met at 09h35.

1. 09h36 Members were given an opportunity for silent prayers or meditation.
2. 09h37 The Speaker made announcements, including the passing away of Mr Xolani Gwala.

The House observed a minute of silence.
3. 09h42 The Speaker read into the record the tabling of the Report of the Multi-party Oversight Visit conducted in Ugu District during October 2019.
4. 09h43 The following Members gave notice of their intention to move motions on the next sitting day of the House:

4.1 Ms J N Cele, ANC, to move:

Le Ndlu:

Ihalalisela ogogo nomkhulu bethu baKwaZulu-Natali abebeyosimela kuma-golden games ka-2019 abedlalelwa eBhayi lapho bedlale ngokukhulu ukuzimisela bephakamisa Ikzn ngokuwina yonke imidlalo behlule wonke ama-province bathola indebe ebizwa nge-overall winner.

Inxusa uNdunankulu waKwaZulu-Natali kanye noMphathiswa Wezemidlalo Nokungcebeleka ukuba bahloniphe futhi bamukele leli thimba lemidlalo yezaguga ka-2019 ngenkulo inhlokomo nenhlonipho futhi lingene emlandweni wakulesi sifundazwe wezemidlalo njengawo wonke amaqembu asuke ebuye nendebe.

Ngakho-ke le Ndlu inquma kanje:

Ukuhlonipha ubaba uKunene osishiye emhlabeni enguSihlalo wezingwevu kuwo lo maspala esikuwo aphinde athole izinga lomngcwabo ohloniphekile wedolobha.

[This House notes:

That our grandmothers and grandfathers represented KwaZulu-Natal at the Golden Games 2019 held in Port Elizabeth; and

That their commitment saw them lifting the overall winner's trophy.

This House therefore resolves:

To ask the Premier of KwaZulu-Natal and the MEC for Sport and Recreation to respectfully honour and welcome this team of senior citizens by recording the [names of the] winning team in the sporting history books of our province; and

To honour Mr Kunene, who passed away during his tenure as Chairperson of the Senior Citizens in this municipality, with an official provincial funeral.]

4.2 Ms P H Mbatha-Cele, ANC, to move:

Le Ndlu inaka:

Isenzo sikahulumeni sokuletha iPhalamende kubantu; lokho kukhombisa ngokusobala ukuthi uhulumeni unguhulumeni wabantu futhi ubeka izimpilo zabantu phambili;

Lokhu kuhle ngoba abantu bathola ithuba lokuzikhulumela ngqo noNdunankulu nabaPhathiswa.

Ngakho-ke le Ndlu inquma kanje:

Ukuncoma igalelo leHhovisi likaSomlomo ngomsebenzi omuhle eliwenzayo wokuvakashela izinhlangano zabantu abahluphekayo nezidinga usizo ngesikhathi iPhalamende likubantu.

[This House notes:

That the government continues to bring the Legislature to the people;

That ours is a government for the people, one that puts the lives of the people first; and

That it is good for people to get an opportunity to interact directly with the Premier and MECs.

This House therefore resolves:

To commend the good work done by the Office of the Speaker; and

To thank them for visiting some non-government organisations whilst the Legislature was in the area.]

4.3 Mr M A Chiliza, ANC, to move:

Le Ndlu iyakuqaphela:

Ngokukhulu ukunengeka ukufa kwabantu bakithi ezingozini zemigwaqo okudlangile kulezi zinsuku kulesi siFundazwe sakithi;

Ininga lalezi zingozi zidalwa ubudedengu kubashayeli. Abanye babo kusuke kuyilabo abathenga izincwadi zokushayela;

Ukuthi kunezigilamkhuba eziziphilisa ngokudayisa izincwadi zokushayela okwandisa isibalo sabantu abashayela bengakwazi ukushayela, bese kudaleka izinhlekelele.

Ngakho-ke le Ndlu inquma kanje:

Ukunxusa umhlonishwa uBheki Ntuli ukuba aqinise isandla kwizephulamthetho emgaqweni nomthetho uqine kakhulu ekubopheni labo abadayisa izincwadi zokushayela.

[This House notes:

With a great sense of anger the number of deaths due to road accidents which are so prevalent in our province;

That the majority of these accidents are the result of driver negligence as some drivers purchase their licenses [illegally]; and

That some criminals make a living by selling drivers' licenses, thereby increasing the number of [illegal] drivers who cause accidents on our roads.

This House therefore resolves:

To call on hon Bheki Ntuli to tighten the screws when it comes to people who contravene the law, and to swiftly arrest those who sell drivers' licenses.]

4.4 Ms M C Frazer (ANC):

This motion was ruled out of order as it had exceeded the maximum length of 100 words, as laid down by Rule 98 (1) of the Standing Rules of the KwaZulu-Natal Legislature.

4.5 Mr P Govender, IFP, to move:

This House notes:

That Ms Nokuthula Khanyile, the HOD of Social Development, is under investigation by the Hawks for alleged corruption and victimisation of staff, among other allegations; and

That the HOD is accused of kleptocracy, self-enrichment, giving misleading performance management information, flawed SCM processes and intimidation of service providers and officials.

This House therefore resolves:

To commend the officials in the Department of Social Development for exposing the corrupt activities by the HOD;

To call on the Hawks to ensure that these claims are thoroughly investigated, without fear or favour; and

To call for the urgent suspension of the HOD pending the [outcome of the] investigation.

4.6 Mr M B Gwala, IFP, to move:

This House notes:

That the IFP's President Emeritus, His Excellency Mangosuthu Buthelezi, in his farewell speech during the IFP's elective conference, called on everyone to take a stand and fight gender-based violence.

This House therefore resolves:

To commend the IFP President, hon V F Hlabisa, for taking the initiative by embarking on a campaign, encouraging all people to fight gender-based violence;

To urge all MPLs, MECs, government employees and the private sector to sign a pledge against gender-based violence; and

To urge all people of KwaZulu-Natal to join hon V F Hlabisa to take a stand against gender-based violence.

4.7 Mr H U de Boer, DA, to move:

This House notes:

That St Lucia is a critically water-scarce area;

That water cuts are threatening tourism and economic development;

That jobs are set to be lost if infrastructure failings in the water network are not addressed urgently; and

That little progress has been made in formulating a new water reticulation scheme, despite government promising to do so for the past five years.

This House resolves:

To call on the MEC for Economic Development, Tourism

and Environmental Affairs to engage all relevant municipal stakeholders and MECs to fast-track permanent plans for a new water supply scheme.

4.8 Mr L M Meyer, DA, to move:

This House notes that:

That water is a basic human right;

That Ugu District Municipality is failing to provide water to residents of the district; and

That the financial situation in Ugu District Municipality is such that it is unable to take the necessary long-term remedial steps to safeguard the bulk water supply.

This House therefore resolves:

To call on the provincial government to intervene and assist so that bulk water supply for the Ugu District can be taken over by Umgeni Water.

4.9 Ms N L Mpayipheli, EFF, to move:

Le Ndlu inaka lokhu:

Ukuthi amanzwi nezindlu zangasese akukho nhlobo emtholampilo waseMbizweni eMzimkhulu Clinic;

Ukuthi abasebenzi bacela usizo komakhelwane ukuzikhulula nangokwamanzi.

Ukuthi emtholampilo waseMalenge khona eMzimkhulu, kule nyanga esiphuma kuyo, kushone umntwana obeyogoma emva kokugoma uye waxhuzula waphuthunyiswa esibhedlela washonela endleleni engakafiki.

Ngakho-ke le Ndlu inquma kanje:

Makukhawuleziswe ukulungiswa kwezintsiza kusebenza.

[This House notes:

That there is no water and toilet facilities at Embizweni Clinic in Umzimkhulu;

That staff have to ask for water and use toilets in nearby houses;

That a child who went for immunisation at Malenge Clinic, Umzimkhulu, died after suffering from seizures a month ago; and

That the child was rushed to hospital, but died on the way there.

This House therefore resolves:

To call on the department to fix the infrastructure.]

4.10 Mr M W Twala, EFF, to move:

This House notes:

That freedom of speech is a constitutional right for all, but most importantly for opposition parties; and

That the Equality Court yesterday ruled against Minister Pravin [Gordhan], a person whom we have identified as an enemy of the people because of his deliberate and conscious undermining of democracy.

This House therefore resolves:

To call on all those who think they are powerful to accept and appreciate that we have a right to make political statements.

4.11 Mr S E Manqele, ACDP, to move:

Le Ndlu inaka lokhu:

Ukuthi [i-ACDP] izwa ukukhathazeka ngesinqumo soMnyango Wezemfundo sokufaka izifundo zokufundisa ngocansi kusukela emazingeni aphantsi kuGrade 4;

Ukuthi i-ACDP ayikuncomi ukuba izingane zifundiswe umkhuba zincane ofana nokuqabuzana, ucansi kusetshenziswa isitho sangemuva neminye imikhuba; izwe liyabulawa.

Ngakho-ke le Ndlu inquma kanje:

Ukunxusa uMnyango Wezemfundo ukuba ukubukeze lokhu okungenani kubuyiselwe isifundo sezenkolo ezinganeni ezincane;

Ukunxusa ukuba kukhuliswe ingane ngendlela okothi uma isindala ihambe ngayo.

[This House notes:

The ACDP's concern after a decision was taken by the Department of Basic Education to introduce sex education in the curriculum for learners from Grade 4 upwards; and

That the ACDP does not approve of children being taught at such a tender age about kissing, anal sex and related acts; this is destroying the country.

This House therefore resolves:

To call on the Department of Basic Education to review this decision and to reinstate religious education instead.

To call for nurturing of children in the way we want them to live when they are adults.]

4.12 Mr V R Mlotshwa, NFP:

This motion was ruled out of order in terms of Standing Rule 98 (3) as laid down by the Standing Rules of the KwaZulu-Natal Legislature.

4.13 Ms M Govender, ANC:

This motion was ruled out of order in terms of Standing Rule 98 (3) as laid down by the Standing Rules of the KwaZulu-Natal Legislature.

4.14 Ms N M Khoza, ANC, to move:

This House notes:

That the Department of Social Development officially handed over computers to NPOs which deal with women and youth development programmes across the province;

That these computers are sponsored by Axiz through the State Information Technology Agency's social responsibility programme;

That handing over these computers was aimed at furthering government's commitment to working smarter and expanding access to leading technology; and

That these NPOs will not be left behind when we talk about the fourth industrial revolution (4IR).

This House therefore resolves:

To encourage NPOs to protect and use these much-needed tools to advance their capabilities in doing the work of communities and improve communication.

4.15 Ms C Q Madlopha, ANC, to move:

This House notes:

The escalation of violence in schools; and

That a number of learners and educators have been injured or killed, resulting in the destabilising of teaching and learning.

This House therefore resolves:

To debate and come up with a comprehensive strategy or plan to curb the scourge of violence in schools.

4.16 Ms N R Majola, ANC, to move:

This House notes:

The epidemiology of oral and dental diseases in South Africa, as per the former Minister of Health's budget speech of May 2017;

That 3.2 million pupils were screened and 500 000 were part of NHI pilot projects, with the following findings –

Speech problems (8 897 cases)
Hearing problems (34 094 cases)
Eye problems (119 340 cases)
Oral health problems (336 679 cases)

That 20 million pupils at primary and secondary schools critically need oral health care.

This House therefore resolves:

To call on uMzumbe Municipality to consider awarding bursaries to students in dental health, audiology, ophthalmology and speech therapy, in line with Vision 2030.

4.17 Ms N P F Mavuso, ANC, to move:

Le Ndlu inaka:

Ukuthi isiShayamthetho saKwaZulu-Natali sivakashele umasipala wasoGwini;

Ukuthi amalungu [aleNdlu] ayiqaphelile inhlanzeko kuMasipala wase-Ray Nkonyeni ngaphansi koholo lukaMphathiswa u-Cynthia Mqwebu elokishini laseGamalakhe;

Ukuthi lokhu kugqame kakhulu ngoba bekuyisikhathi sokusebenza lapho bekungekho maphepha agcwele emigwaqeni kungekho nabafundi abehla benyuka begqoke umfaniswano wesikole emigwaqeni ngesikhathi sokufunda nokufundisa.

Ngakho-ke le Ndlu inquma kanje:

Ukuba nabanye omasipala besifundazwe bafunde kuMasipala wase-Ray Nkonyeni ngokusebenza okuhle;

Ukunxenxa uMnyango wakwa-COGTA oholwa umphathiswa u-Hlomuka ukuba uqinise emkhankasweni wawo wamadolobha namalokishi ahlanzekile;

Lokhu kulekelela ukuba kube nomoya namanzi ahlanzekileyo ikakhulukazi kulesi simo sokuguquguquka kwesimo sezulu.

[This House notes:

That during the Legislature's visit to Ugu district, Members observed the cleanliness of Gamalakhe Township in the Ray Nkonyeni Municipality, under the leadership of Cynthia Mqwebu;

That this was clear for all to see since the visit to the area took place during working hours; and

That no papers were blowing about, and no learners in school uniform were seen loitering around during school hours.

This House therefore resolves:

To call on other municipalities in the province to take a leaf out of Ray Nkonyeni Municipality's best practice book; and

To call on hon Hlomuka, MEC for Co-operative Governance and Traditional Affairs, to strengthen the clean city and township campaign as this will lead to people breathing in clean air and drinking clean water, especially during this era of global warming.]

4.18 Ms H G S Mavimbela, ANC, to move:

This House notes:

The sad news that radio presenter Xolani Gwala passed away of stomach cancer at the beginning of November which is regarded as Cancer Awareness Month.

This House therefore resolves:

To call on MPLs and members of communities –

- To quit smoking;
- To stop using substances which cause disease;
- To exercise at least three times a week;
- To adopt a healthy lifestyle and eating regime to enable their bodies to fight disease;
- To get screened regularly so that diseases can be detected at an early stage; and

To call on all Members to be advocates of cancer awareness.

4.19 Mr S W Mshengu, ANC, to move:

This motion was ruled out of order in terms of Standing Rule 98 (3) as laid down by the Standing Rules of the KwaZulu-Natal Legislature.

4.20 Mr M Khawula, IFP, to move:

Le Ndlu:

Izwakalisa ukudumala okushaqisayo ngesenzo sikaNdunankulu wesifundazwe uMnu uZikalala kule nkundla izolo.

Enikwe ithuba lokukhuluma nabantu besifundazwe basoGwini ngezindaba ezibalulekile zentuthuko, uMnu uZikalala unqume ukukhwela adilike phezu kweQembu leNkatha ngokungenasidingo, nanjengoba kwenzeka mhlazane ebekwa ngoNtulikazi, kwaphinda futhi ngephalamende labantu abasha kodwa sabekezela.

Lokhu kukhanye kwathi bha ukuthi lesi sifundazwe sinoNdunankulu ongenandaba nokusebenzela isizwe ngokuthula nokubambisana ebesicabanga ukuthi kuzokwakheka;

Ukugeza izandla ngoNdunankulu ongafuni ukukhula ngomqondo ngalolu hlobo;

Ukunxusa iQembu likaKhongolose ukuthuma uZikalala lapho kuliwa khona ukuze isifundazwe sizoba noNdunankulu ozosebenza ngokuthula nokubambisana.

[This House notes:

The disappointing behaviour by hon Zikalala, Premier of KwaZulu-Natal, when he stood at this podium yesterday to address the people of Ugu District about important development issues;

Hon Zikalala chose to attack the IFP instead, as he did during his inauguration and at the Youth Parliament in July – and we kept quiet throughout;

It is clear that our province has a Premier who does not care about serving the country in harmony and co-operation, as we had originally hoped; and

That the Premier gloated like the proverbial emperor without clothes is a clear indication that he still has a long way to go.

This House therefore resolves:

To wash our hands off the Premier who shows such a basic level of maturity; and

To call on the ANC to deploy Zikalala where there are wars so that the province can get a Premier who will work in harmony with other parties.]

4.21 Mr M J Mazibuko, IFP, to move:

Le Ndlu inaka lokhu:

Iphatheke kabuhlungu ngesenzo esintula ukuhlakanipha sikaMhlonishwa uNdunankulu uZikalala izolo kule nkundla. UKhuzeni usebenzise ithuba ukushishiliza nge-IFP kungenasidingo, engaqali ngoba nangoNtulikazi ebekwa washishiliza ngathi; waphinda futhi ngePhalamende lentsha

Kucacile ukuthi lesi Sifundazwe asinaNdunankulu sizihlalele nje;

Ukuthi uKhuzeni uyingozi ehamba ngezinyawo engabuyisela lesi Sifundazwe obhukwini lokungqubuzana lwemiyaka eyedlule, olwadlula nemiphefumulo eminingi.

UKhuzeni usagcwele ihlathi lobuphakimpi, lobu thina [kule Ndlu] esingasenaso isikhathi sabo.

Ngakho-ke le Ndlu inquma:

Ukunxusa amalungu [ale Ndlu] aphasile ukuba asizane ukunqanda le ngozi esibhekene nayo enguNdunankulu.

Ukunxusa i-ANC ukuba ibuyisele uNdunankulu esikoleni ayofunda ngobuholi nomthwalo awuthwele njengoNdunankulu wokuhlanganisa abantu, adale ukubuyisana okuzoyisa isiFundazwe phambili

[This House notes:

Hon Premier Zikalala's disappointing behaviour in this Chamber yesterday, when he used the opportunity given to him to attack the IFP without any provocation;

This was not the first time; he did it in July when he was inaugurated and he did it again during the Youth Parliament;

It is obvious that this province does not have a suitable Premier;

Hon Khuzeni is a ticking time bomb that may take this province back to the days when political killings and the loss of too many lives were rife; and

Hon Khuzeni is still stuck in a war-stirring era which Members of this House left behind a long time ago.

This House therefore resolves:

To ask Members of this House to support each other in stopping this danger that we are facing – the Premier; and

To call on the ANC to send the Premier on a course where he can be taught about leadership and the mammoth task of leading a province and uniting people, and achieve reconciliation that will take our province forward.]

4.22 Ms E Rabe, DA, to move:

This House notes:

That the report tabled by MEC Khoza at the *Taking the Legislature to the People* initiative reflects serious social ills and special needs among the residents of rural areas in Ugu Municipal District.

This House therefore resolves:

To call on MEC Khoza and the Department of Social Development to be proactive instead of reactive, and to

initiate profiling in Ugu District without being prompted to do so by citizens who have been interviewed, in order to provide effective and necessary services to those in need.

4.23 Dr R Viranna, DA, to move:

This House notes:

Ugu District has had a water crisis for the past five years;

This has had a major impact on tourism, a major job creation driver;

Small businesses on the South Coast have closed, leaving thousands unemployed;

Instead of supporting South Coast businesses, Edtea is today using government funds to campaign in Msunduzi (Ward 33) under the guise of small business development, as per the advertisement; and

This is completely unethical.

This House therefore resolves:

To call on MEC Dube-Ncube to give a detailed explanation to the relevant portfolio committee about the lack of support for South Coast businesses during the water crisis in Ugu.

4.24 Ms N J Nkwanyana, IFP, to move:

Le Ndlu:

Iyazwelana nomndeni wakwaZwane, KwaMashu oshonelwe ubaba wekhaya uMnu. Bongani Zwane ngoMsombuluko ebusuku ngenxa yokungalitholi usizo lwezempilo ngendlela efanele emtholampilo i-Poly Clinic KwaMashu entsha lapho eshonele ezandleni zendodana yakhe ngaphakathi emtholampilo ngoba odokotela nabahlengikazi bengamnakile;

Inaka ukuthi omunye wodokotela kulo mtholampilo uthi inkinga ababhekene nayo ukushoda kodokotela kanye nezinye izinsiza kusebenza.

Ngakho-ke le Ndlu inquma kanje:

Ukunxusa uNgqongqoshe Wezempilo KwaZulu-Natali uMhlonishwa uNomagugu Simelane-Zulu ukuba enze uphenyo olunzulu ngalezi zinsolo ezibucayi ezenziwe umndeni wakwaZwane zokuthi ushonelwe ubaba wekhaya ngenxa yobudedengu babasebenzi bezempilo e-Poly Clinic KwaMashu bese bonke abanecala lobudedengu bathathelwe izinyathelo ezinqala;

Ukunxusa futhi uNgqongqoshe Wezempilo KwaZulu-Natali ukuthi akayisukumele phezulu inkinga yokushoda kwabasebenzi bezempilo emitholampilo nasezibhedlela.

[This House:

Wishes to pass its condolences to the Zwane family after the passing away of their father, Mr Bongani Zwane, on Monday;

Notes that Mr Zwane's death was due to doctors and nurses at the Poly Clinic not giving him the necessary care; and

One of the doctors who work at this clinic said the shortage of doctors and other resources are a challenge.

This House therefore resolves:

To call on the MEC for Health, hon Nomagugu Simelane-Zulu, to conduct an in-depth investigation into the Zwane family's sensitive allegations about employees at the Poly Clinic in KwaMashu so that those who are found guilty of negligence can be dealt with harshly; and

To call on the MEC for Health in KwaZulu-Natal to deal decisively with the shortage of health workers in our healthcare facilities.]

4.25 Mr S Moodley (IFP):

This motion was ruled out of order as it had exceeded the maximum length of 100 words, as laid down by Rule 98 (1) of the Standing Rules of the KwaZulu-Natal Legislature.

4.26 Mr T V Xulu, ANC, to move:

This House:

Calls for a debate on the ANC's pledge to change the Constitution to accelerate expropriation of land without compensation to address racially skewed patterns of land ownership dating back to apartheid and colonial rule as this will expose the conservative DA's opposition to the amendment of section 25 of the Constitution which is aimed at defending privileged white middle-class interests and preserving the legacy of apartheid and colonial rule by denying the majority of people in this country access to land ownership.

4.27 Ms G N Swartbooi-Ntombela, ANC, to move:

Le Ndlu inaka:

Ngakho-ke le Ndlu inquma kanje:

Ukugqugquzela imiphakathi ukuthi ifake izingane zayo kulezi zinkulisa ukuze zithi ziqala ezikoleni zibe sezikulungele ukufunda;

Nokuthi bazivikele izinqalazizinda ezakhiwa nguhulumeni ukuletha impilo engcono kubantu.

[This House notes:

That on 23 August 2019, the Department of Social Development handed over a revamped Early Childhood Development Centre to Emasomini Village, KwaMaphumulo, in Ilembe District;

That the department had allocated R6 million for this project; and

That this crèche is run by an NPO that is funded by the department.

This House therefore resolves:

To encourage communities to enroll their children in this crèche so that they are ready to learn by the time they start school; and

To protect this infrastructure that was built by the government in pursuit of a better life for the people.]

4.28 Mr S M Sonjica, ANC:

This motion was ruled out of order as it had exceeded the maximum length of 100 words, as laid down by Rule 98 (1) of the Standing Rules of the KwaZulu-Natal Legislature.

4.29 Mr N Ntombela, ANC, to move:

Le Ndlu inaka lokhu:

Ukuthi ngaphesheya kuyehla kuyenyuka, kusinda kuyehlela;

Izigigaba nezigemegeme ezikhungethe iqembu le-Democratic Alliance zikubeka obala ukuthi abebala bayayithatha into yabo manje.

Ukwesula esikhundleni naseqenjini kweMeya u-Mashaba, ukwehla esikhundleni kukaMmusi Maimane, ukubuya kumhlalaphansi kukagogo u-Helen Zille kukubeka obala ukuthi i-DA iqembu labamhlophe elimele izidingo nezimfuno zabo.

Ngakho-ke le Ndlu inquma kanje:

Ukwexwayisa nokuqwashisa abantu bakithi bengabadi ukuthi bangaphinde balutheke beluthwa abebala ukufeza izinhloso zabo zokuvikela abanakho abakuthola bekuzuza ngobandlululo;

Umbuzo uthi ubani olandelayo? I-DA ayisafani.

[This House notes:

That the DA is clearly going through some turmoil;

That the latest developments in the DA shows that white people are intent on taking back what is theirs; and

That Mayor Mashaba and Mr Mmusi Maimane's resignations and grandma Helen Zille's return are clear indications that the DA is a political party which represents white people and their interests.

This House therefore resolves:

To caution and warn our people never to be fooled by white people who use them in order to protect the wealth they amassed during the apartheid era.

What happened to Maimane and De Lille is exactly what happened to Lindiwe Mazibuko. The big question is: Who is next? The DA is no longer the same party.]

4.30 Mr T S Mtshali, ANC, to move:

This House notes:

That the Department of Social Development has partnered with KFC's *Add Hope* foundation to assist NPOs with much-needed resources in dealing with children's development and fighting poverty; and
