THURSDAY, 28 FEBRUARY 2019

The House met at 10h08.

1. 10h09 Members were given an opportunity for silent prayers or meditation.
2. 10h10 The Speaker made announcements.
3. 10h13 The Speaker read into the record the tabling of the:
 - (i) In-Year Monitoring Report (IYM), December 2018/19 and January 2018/19; and
 - (ii) Third Quarter and Consolidated Performance Report (October to December and April to December 2018/2019).
4. 10h15 The following Members gave notice of their intention to move the following motions on the next sitting day of the House.

4.1 Ms W G Thusi, ANC, to move:

This House notes:

That 300 young people from all provincial districts are currently meeting at the SA Infantry 5 Army Base in Ladysmith where they are being hosted by the Department

of Social Development and the Department of Defence and Military Veterans; and

That the young people are testifying how the ANC-led government in KwaZulu-Natal has assisted them by improving their lives in all aspects.

This House therefore resolves:

To congratulate the ANC-led government for looking after the young people of this province who are the future of the country.

4.2 Ms N Dube-Ncube, ANC, to move:

This House notes:

The negative impact of corruption when millions of rands, reserved for service delivery, were siphoned off by corrupt officials who lined their own pockets at the expense of our people in Ingwe.

This House therefore resolves:

To welcome the 12-year prison sentence, without the option of a fine or suspension, handed down by the Commercial Crimes Court to the mastermind behind the theft of R7.5 million after a Cogta investigation; and

To call for harsh prison sentences which will serve as a lesson to all public servants who disregard their code of conduct which requires them to execute their duties with integrity.

4.3 Mr S A Duma, ANC, to move:

The House notes:

The selflessness and quick response of Mr Mathanda Nzama, our Sergeant-at-Arms, who went beyond the call of duty in saving the Premier's life yesterday; and

That public servants of his caliber should be honoured and saluted.

This House therefore resolves:

To give honour where honour is due – Wosiyane, you deserve a special award;

To thank this gentleman for his great work; and

To encourage others to follow suit.

4.4 Mr F A Rodgers, DA, to move:

This House notes:

At yesterday's SOPA the Premier waxed lyrically about the ANC's successes with water delivery projects;

At that very moment uMzimkhulu was experiencing its third day of violent protests regarding non-existent water delivery;

This town has the necessary infrastructure, but an incompetent ANC government has failed in its most basic responsibilities;

Even the IEC has verified that KwaZulu-Natal has the most service delivery protests in South Africa.

This House therefore resolves:

To ask the ANC: Are you proud of this achievement? Is this what *Thuma Mina* means? Is this how you care for the people of KwaZulu-Natal?

It's time for change. Woza May, woza! [*Bring on the month of May!*]

4.5 Mr M J Mazibuko, IFP, to move:

Le Ndlu:

Izizwa inokudumala ngezigidaba esezisabalele ezweni lakithi zabafundisi-mbumbulu abadlala ngabantu ngoba behluphekile bebathembisa izulu nomhlaba

Kepha ukuthuthuleka kwezinkumbi zabantu kulaba bafundisi-mbumbulu kuyizinkomba zokuthi abantu bakithi

bakhungethwe yizinhlupheko esezibenza balandele noma ngubani obethembisa ikhenani.

Siyakunaka ukuthi leli zwe lineshwa ngoba nakwezombusazwe bakhona abafundisi-mbumbulu abafana noLukau no-OMotoso abayenga abantu bakithi ngezethembiso ezingekho

Ngakho-ke le Ndlu inquma:

Ukunxusa uhulumeni ukuba asisukumele lesi sihlava sezimpisi ezembethe izikhumba zezimvu zizenza abefundisi

Ukunxusa abantu bakithi ukuba bangavumeli izinhlupheko zibadunge imiqondo balandele yonke imidlambila

Ukubaxusa futhi abantu bakithi ukuba baqaphele nezimpisi zombusazwe ezibayenga ngamabala kanti ziqonde ukubenza izitebhisi

Ukubakhumbuza abantu bakithi ukuthi bangayethemba i-IFP njengoba kubhekwe [okhethweni] luka-2019.

[This House:

Feels disappointed about certain incidents that have occurred and which are being perpetuated in our country by pseudo pastors who get a kick out of playing games with people's sufferings by promising them heaven and earth;

Notes that the throngs of congregants who attend these pseudo pastors' churches are an indication that our people are overcome by hardship, causing them to follow anyone who promises them [the proverbial land of] Canaan;

Notes that this country unfortunately also has to contend with pseudo pastors in the political domain, such as the likes of Lukau and Omotoso who lure our people with empty promises.

This House therefore resolves:

To call on government to express a dim view at this scourge of hyenas who masquerade as sheep while acting as pastors;

To urge our people not to allow their suffering to blind them into following these charlatans;

To urge our people to be careful of political hyenas who use sweet and seductive words while their real intention is to exploit our people for their own personal upward mobility; and

To remind our people that they can trust the IFP as we head towards the 2019 elections.]

1.6 Ms P H Khuzwayo, NFP, to move:

Le Ndlu:

Iyakunaka ukushaywa indiva kwalabo abaphila nokukhubazeka. Kuyichilo ukuthi njengohulumeni singakubeki kugqame ukusizakala nokunakekeleka kwabo.

Ngakho-le le Ndlu inquma kanje:

Ukunxusa uhulumeni aqinisekise ukuba nohla-mininingwane (database) lwabo bonke ngokwezindawo abahlala kuzo oluqukethe iziqu abanazo kanye namakhono emisebenzi abayenzayo.

Ukuqokelelwa kohla-mininingwane kuyobe sekulekelela ukuba baqasheke futhi banikwe imisebenzi ngokweminyango kahulumeni (amathenda) noma basebenze ezinkampanini ezinkulu ukuze kukhule izinkampani zabo.

[This House:

Notes that people living with disabilities are being neglected. It is a disgrace that government does not clearly prioritise their service and care.

This House therefore resolves:

To call for more employment opportunities which will benefit people living with disabilities in the next term;

To urge government to establish a database containing their contact details and addresses. The database should also list their qualifications and specific skills which they possess;

To ensure that this database will assist them in gaining employment and being awarded tenders issued by government departments, or for them to be subcontracted by big companies in order to grow their own company profiles.]

1.7 Mr V Ndlovu, EFF, to move:

Le Ndlu iyakunaka ukuthi:

I-African National Corruption ibonakala ngodaka ukuthi umfula we-Bosasa iwuwelile.

Ilinganiselwa ngaphezu kuka-R40 million imali enikelwe i-Bosasa kuKhongolose nokuvunywe yiyo le nhlango ngokuyenzelela ekutholeni amathenda kuhulumeni obusayo.

Benzelwe ama-*birthday cakes*, utshwala, imali, ama-*lunch packs* and golf days for Supra [Mahumapelo].

In 2016 Bosasa hosted parties for the ANC to the tune of R3.5 million while our poor black people were starving.

Ngakho-ke le Ndlu inquma kanje:

Ukuthi i-EFF iyona engahlonizi ukuthi awaqedwe amathenda.

Abaphenywe abathinteka kwi-Bosasa futhi baboshwe bonke.

[This House notes:

That African National Corruption is visible through the mud that indeed crossed the Bosasa river;

Bosasa donations to the ANC are estimated at more than R40 million, by this organisation's own admission, through favours to get tenders from the current government.

They received birthday cakes, alcohol, money, lunch packs and golf days for Supra (Mahumapelo).

In 2016 Bosasa hosted parties for the ANC to the tune of R3.5 million while our poor black people were starving.

This House therefore resolves:

To acknowledge that the EFF is the only party who has stated, without any fear of contradiction, that the tender system should be abolished; and

To investigate and arrest all people who were implicated in Bosasagate.]

1.8 Ms S Thakur-Rajbansi, MF, to move:

This House notes:

The rampant urban land grabs and invasions in eThekweni, especially in the former Indian areas of Clare Estate and Cato Crest; and

The acknowledgement by the Premier at the State of the Province address that Goal 7 of the PGDS, which had been adopted for spatial equity, remains work towards reducing spatial inequalities.

This House therefore resolves:

To deal with the spiraling social ills which are hurting Indian communities who are generally peace-loving; and

To call on the Premier to show political leadership by intervening with a multi-government task team of relevant stakeholders to deal with this urban lawlessness.

1.9 Mr S J Gcabashe, ANC, to move:

Le Ndlu inaka lokhu:

[This House notes:

That there are two things which people of this province have witnessed – one good thing and one very bad thing;

That there was a spirit of unity, humanity and sympathy among [Members of] this House and invited guests when the Premier fell ill during the presentation of his State of the Province address. Their attitude was commendable.

That it was disappointing to see some members on the other side of the House spitting after the former President, Mr J G Zuma, greeted them with a handshake.

That for us as Africans, who are also members of the Zulu nation, respect is paramount, even if you have quarreled with or despise a person.

This kind of behaviour was shameful and disgraceful to our children.]

1.10 Mr M E Dlungwana, ANC, to move:

This House notes:

That the ANC government in KwaZulu-Natal has realised the need to provide sanitary towels to needy learners;

That the national Minister of Finance has allocated a budget for the nation roll-out of the very important programme; and

That today is the national launch of the sanitary towels programme in Mpumalanga.

This House therefore resolves:

To congratulate the ANC government for providing sanitary towels to all needy learners in our country;

To congratulate President Matamela Ramaphosa for the

national roll-out of the sanitary towel programme; and

To congratulate the ANC government for caring about the lives of our learners.

1.11 Ms LC Bebee, ANC, to move:

This House notes:

The sentencing of Vicki Momberg for racism ukukhumbuza i-DA ukuthi asikhohliwe [*should remind the DA that we are well aware that the*] masses are not blind.

This House therefore resolves:

To deal with racism expressed by farmers towards their workers and the community as a criminal offence as there now is a precedent for it.

1.12 Mr G Mari, DA, to move:

This House notes:

The continuing destruction of play lots to build houses by developers in Phoenix, eThekweni;

That play lots are community facilities provided for children's recreation; and

That Cde Stanley Moonsamy has abandoned his campaign to stop this, contrary to MEC Pillay.

This House therefore resolves:

To call on the MEC for Human Settlements to immediately halt the destruction of play lots in Phoenix;

To rezone the play lots that have been destroyed; and

To set up a commission of inquiry to investigate these allocations to developers.

1.13 Mr S Moodley, IFP, to move:

This House notes:

That we stand on the threshold of yet another national election; and

That we are here to serve the people of KwaZulu-Natal and lead by example.

This House therefore resolves:

To collectively adopt a spirit of unity and nobility of purpose as we head for the polls on 8 May 2019;

To urge all political parties to strictly adhere to the rules which govern a free and fair election; and

To pray for God's guidance and blessings so that we will be emboldened to lead with honour, integrity and respect for all stakeholders.

1.14 Ms M Govender, ANC, to move:

This House notes:

Today marks exactly 33 years since the assassination of Swedish Prime Minister Olof Palme, a staunch supporter of the South African liberation struggle and vociferous opponent of apartheid; and

That those responsible for his murder have never been brought to book, despite allegations that South African apartheid agents were involved in this heinous crime.

This House therefore resolves:

To call for an investigation into these allegations so that those who may have been involved in the assassination of Olof Palme can be brought to book.

1.15 Ms B N Sithole-Moloi, ANC, to move:

Le Ndlu inaka:

Ukuthi inyanga kaNhlolanja inyanga lapho umhlaba ugubha futhi uqhakambisa ulimi lwebele.

[*This House notes:*

That February is the month during which the world celebrates international mother-tongue [languages].

That to be conversant in and proud of one's language is important as it teaches us the history and culture of our nations;

That this province was also counted [as being a part of this movement] when it successfully celebrated this day on 21 February 2019 in Amajuba District.

This celebration commenced with a march of all races, highlighting their various languages.

This House therefore resolves:

To move with speed in amending the language policy;

To promote the learning of other languages, including sign language; and

To strengthen co-operation by enhancing peace and tolerance in our province.]

1.16 Ms N R Majola, ANC, to move:

Le Ndlu:

Iyawuncoma uMnyango Wezokuphepha Nokuxhumana Komphakathi ubambisene nowezeMpilo ngokusebenza ngokuzikhandla ekulandeleni umshophi wengane eyazalwa ngumama wase-Newlands wabona kukuhle ukuyilahla kwi-drain kunokuba asondelelane nosonhlalakahle abeke ingxaki yakhe.

Ngakho-ke le Ndlu inquma kanje:

Sithi ke singuKhongolose akukho nokuncane okuyakusoyisa. Qhubeka mbutho wabantu wenze okuthunye ngabantu bezwe lo Mzantsi Afrika.

[This House:

Commends the Department of Community Safety and Liaison and the Department of Health which worked tirelessly in following up on an infant born to a mother in Newlands who saw fit to throw the infant down a drain instead of approaching social workers to explain any predicament she was facing;

Both these departments worked hard to address the situation, and were assisted by members of the community who had heard the plaintive cries of the infant;

The department, led by Dinangwe, intervened and rushed the baby to iNkosi Albert Luthuli Hospital where it received intensive care. The infant's life was ultimately saved;

Mbimbi's department started searching for the perpetrator and she was caught in no time.

This House therefore resolves:

To note that nothing will scare the ANC, so proceed People's Movement, and do what you are mandated to do by the people of South Africa.]

1.17 Dr I Keeka, DA, to move:

This motion was ruled out of order as it had exceeded the maximum length of 100 words, as laid down by Rule 98 (1) of the Standing Rules of the KwaZulu-Natal Legislature.

1.18 Mr N Ntombela, ANC, to move:

This House notes:

On 25 February 1991, Inkosi Mhlabunzima Maphumulo was brutally assassinated for his convictions and resilient fight against apartheid and all its manifestations; and

Inkosi Maphumulo, the founding president of Contralesa, chartered previously unchartered waters in uniting amakhosi in the fight against apartheid and the oppression of his people.

This House therefore resolves:

To remember where we come from as we prepare for the forthcoming general elections on 8 May 1991; and

To remind ourselves that Inkosi Maphumulo's blood, like that of many others, was not spilled in vain since it nourished the tree of liberation under which we sit today.

1.19 Ms V V Tambo, ANC, to move:

Le Ndlu:

This House therefore resolves:

The best that eThekweni could do in dealing with the situation was to purchase Casspirs worth R20 million – quite reminiscent of the apartheid era, I must add.

This House therefore resolves:

To call for an effective political intervention on the part of government, instead of preparing to meet violence with violence – and that against the very people it has let down; and

To call on poor, homeless people not to forget the ANC's false promises when they vote during the 2019 elections.

1.22 Ms N M Khoza, ANC, to move:

This House notes:

That in most cases the lack of employment in this country is due to the impact of legislation which was enacted during the apartheid era.

One such piece of legislation is the Estate Agency Act of 1976 which favours job opportunities only for our white counterparts in the property industry.

This House therefore resolves:

To welcome the Property Practitioners Bill, which was proposed by the ANC, which will open up opportunities for black people in this industry.]

1.24 Ms M M Ntuli, ANC, to move:

Le Ndlu inaka:

- to urgently investigate all allegations of abuse;
- not to traumatise the children any further through forced relocations; and
- to publicly apologise to parents and children who have been affected by ill-advised actions.

That Ezemvelo [KZN] Wildlife today arrested two rhino poaching suspects at Nkangala outside Hluhluwe's Imfolozi Park after a tip-off from community members.

This House therefore resolves:

To commend the community of Nkangala who proved that by working together we can do more.

1.27 Mr S M Sonjica, ANC, to move:

This House notes:

That the imperialist United States of America is imposing its puppet in Venezuela against the democratically elected government and President Maduro.

This House therefore resolves:
