Honourable Members, it is with profound sadness that we formally note the passing away of:

- 2.1 Members of the Senior Citizen's Forum and also Members of the Senior Citizens' Parliament. They are
  - Ms G Magwaza, Chairperson Ulundi Municipality and Zululand District;

- Ms M N Mthimkhulu, Former Chairperson Ndumeni Municipality and Mzinyathi District;
- Ms Z Zulu, Co-ordinator Mtubatuba Municipality;
- Mr T Mgobhozi, Chairperson Ilembe District;
- Ms N Makhoba, Former Chairperson Nquthu Municipality;
- Mr Kheswa, Chairperson Mtubatuba Municipality;
- Ms H Ntuli, Chairperson Alfred Duma Municipality;
- Mr P Nene, Deputy Chairperson Ugu District and Chairperson – Umzumbe Municipality; and
- Ms Ntombizonke Phindile Muriel Mthabela, representing the NFP.
- 2.2 Inkosi Nkanyiso Mncube of Mbokodwebomvu Traditional Council. Inkosi Mncube was killed with his uncle in a hail of bullets when gunmen opened fire on the vehicle they were travelling on the R68 in Babanango;
- 2.3 Mr Mbulaheni David Malada, African National Congress (ANC) and uMkhonto we Sizwe (MK) veteran, passed away at his home in Makonde village outside Thohoyandou in Limpopo at the age of 67.

Mr Malada, who was affectionately called "Peter Dambuza", took part in various battles, including the SA Defence Force Matola raid in Maputo in 1981 and the Sibasa operation, also in 1981. Malada was a member of the mayoral committee in the Vhembe District Municipality. He was also the head of the portfolio committee for planning;

- 2.4 Mr Wilmoth Sibisi, father of Mrs Nomusa Gina (KZN Legislature Procedural Services) and Mr Bongani Sibisi (Former Chief Operations Officer of the Legislature) who was laid to rest on Saturday, 22 August 2020;
- 2.5 Asithandile "Kwasa" Zozo, a 19-year-old student of the University of Witwatersrand who was allegedly stabbed to death by her boyfriend for refusing to be with him;
- 2.6 Constable Thandekile Promise Sikhakhane (35) who was gunned down in Thembalethu Road, Ezakheni B-Section, on Tuesday evening (August 18);
- 2.7 Mr Sibusiso Joseph Mchunu, the Richmond Local Municipality Mayor, who passed away on 13 August and was laid to rest on 18 August 2020;
- 2.8 Six young women from the South Coast in uMthwalume who were allegedly murdered by a serial killer;
- 2.9 Mr Mack Jack, Northern Cape MEC for Education, who passed away on 12 August 2020 and was laid to rest on 16 August 2020;
- 2.10 Struggle stalwart Mr John Nkadimeng who died at the age of 93. This selfless and courageous stalwart made an immense contribution to South Africa's democracy.

He was bestowed with the honour of Isithwalandwe at his home in Kew last year. Mr Nkadimeng had been among the 156 congress activists who were detained during the defiance campaign in 1952 and charged with treason in the 1956 treason trial. He went into exile, taking refuge in numerous neighbouring countries;

2.11 Anti-apartheid activist Mr Devadass Paul David who died of natural causes at his home in KwaDukuza. He was 79 years old. Mr David was a hero, struggle veteran, icon, legend and the last surviving member of the Consulate Six; 2.12 Prince Mandla Zulu, a half-brother of King Goodwill Zwelithini, who passed away late on Wednesday, 5 August 2020. Prince Mandla, the son of King Solomon (eYibindini Royal House), was also a national executive member of the IFP.

The prince's death comes at a time when the monarch was still in mourning after two princesses, Nobuhle and Busi, who lived at Mbelebeleni Royal Residence in KwaMashu, Durban, passed away in quick succession;

- **2.14** On behalf of the Legislature, I wish to request Members of the Legislature to remember all those that have succumbed to the Covid-19 pandemic in your thoughts and prayers.

Hon Members, you are reminded that this Virtual Sitting will be conducted in terms of the Rules for Virtual Meetings, read with our existing Standing Rules.

In terms of Rule 6 of the Rules for Virtual Meetings, the quorum requirement for Virtual Sittings of the House are provided for in the Constitution and the Standing Rules of the KZN Legislature. Standing Rule 44 of the Standing Rules provides as follows:

"At least one third of all the members of the Legislature must be present to constitute a plenary meeting of the Legislature ..."

The Rules for Virtual Meetings also define "present" as follows:

"present" means the attendance of a Member in a virtual meeting by electronic means in a manner that allows the <u>Member to join and participate</u> in the meeting.

The Secretary has confirmed that we have the required one-third of Members present in order to commence with the Virtual Sitting. The Sitting is therefore properly constituted.

### Party voting

Rule 7(d) of the Rules for Virtual Sittings also state that-

"The presiding officer must, <u>before or at the start of the</u> <u>discussion on the matter</u>, <u>expressly inform Members</u> if a party vote will be taken." In line with the above, I confirm that the Debate on the National Gambling Amendment Bill [B27B-2018] and the voting thereon will be done on a party-by-party basis. A party vote is a collective vote on behalf of all the members of a Party present at this virtual Sitting, up to the total membership of that party in the sitting.

However, I will allow an opportunity for any individual Member to vote differently from his/her party, or to abstain, if any Member wishes to do so.
