Honourable Members, let us take a moment to remember in our thoughts and prayers all those souls who have departed from us, either due to Covid-19 or through natural or unnatural causes:

2.1 - His Majesty, King Goodwill Zwelithini kaBhekuzulu, Ubhejane phuma esiqiwini, one of the most renowned monarchs on the African continent, and perhaps globally, a much-loved visionary, a straight

talker and custodian of Zulu traditions and customs, who revived many cultural practices, including Umkhosi woMhlanga – also known as the Reed Dance ceremony – and uMkhosi wokweShwama – also known as the First Fruit. His Majesty was the longest-serving monarch in Zulu history, reigning for half a century, through the apartheid era and the transition to our multi-racial democracy. His Majesty the King was also a pillar of strength to this Legislature through his advice and guidance over the years.

#### 3.1 RULING ON VIRTUAL SITTING

Hon Members, you are reminded that this Virtual Sitting is being conducted in terms of the Rules for Virtual Meetings, read with our existing Standing Rules.

In terms of Rule 6 of the Rules for Virtual Meetings, the quorum requirement for Virtual Sittings of the House is provided for in the Constitution and the Standing Rules of the KZN Legislature. Standing Rule 44 of the Standing Rules provides as follows:

"At least one third of all the members of the Legislature must be present to constitute a plenary meeting of the Legislature ..."

The Rules for Virtual Meetings also define "present" as follows:

"present" means the attendance of a Member in a virtual meeting by electronic means in a manner that allows the Member to join and participate in the meeting.

The Secretary has confirmed that we have the required one-third of Members present in order to commence with the Virtual Sitting. The Sitting is therefore properly constituted.

### Party voting

Rule 7(d) of the Rules for Virtual Sittings also state that-

"The presiding officer must, before or at the start of the discussion on the matter, expressly inform Members if a party vote will be taken."

In line with the above, I wish to confirm that voting will take place after the debate on the KZN Funding of Represented Political Parties Act Repeal Bill of 2021 and the debate on the Third Adjustments Appropriation Bill of 2021. Voting will be done on a party-by-party basis. A party vote is a collective vote on behalf of all the Members of a Party present at this Virtual Sitting, up to the total membership of that party in the sitting.

However, I will allow an opportunity for any individual Member to vote differently from his/her party, or for any individual Member to abstain, if he/she wishes to do so.
