4. 13h20 Mr B M Zuma moved the following motion in terms of Standing Rule 97(g):

**MOTION/ RESOLUTION OF THE HOUSE
REGARDING THE APPOINTMENT OF THE IFP'S
PERMANENT DELEGATE TO THE NCOP**

This motion is a motion without notice moved under Standing Rule 97(g), with the unanimous concurrence of all the Members present in the House.

The Presiding Officer is requested to put the motion to the vote for approval as a Resolution of the House under Standing Rule 95(2).

This House notes:

1. That according to the formula set out in section 2(2) of the Determination of Delegates (National Council of Provinces) Act, 1998 (Act No. 69 of 1998), the IFP is entitled to one (1) permanent delegate in the KwaZulu-Natal provincial delegation to the National Council of Provinces;
2. That hon Simon Ezra Mfayela, who had previously been appointed as the IFP's permanent delegate to the NCOP, has sadly passed away;
3. That the IFP has nominated Mr Xolani Ngwezi as the new IFP's permanent delegate to the NCOP and that this nomination was received by the Speaker on Tuesday, the 26th January 2021; and
4. That, in terms of the National Council of Provinces (Permanent Delegates Vacancies) Act, (Act No. 17 of 1997), the Legislature is required to appoint a new permanent delegate within 14 days of the date on which the nomination is received by the Speaker.

This House therefore resolves:

1. To appoint **Mr X Ngwezi** as the IFP's permanent delegate to the KwaZulu-Natal provincial delegation to the National Council of Provinces.
