  - 2.1 Honourable Members, let us take a moment to remember all the departed souls from this world. They will forever remain in our thoughts and will be missed beyond measure:
    - Prof James Steven Mzilikazi Khumalo, composer and

professor emeritus of African languages at the University of the Witwatersrand;

- Mr Dan Mabuyakhulu, former Provincial Chairperson of SADTU in KwaZulu-Natal;
- Ms Thandi Matiwane; a senior caucus member of staff who has been in the service for many years;
- Mr Geoff Makhubo, Executive Mayor of the City of Johannesburg and Chairperson of the ANC's Greater Johannesburg Region;
- Mr Michael Zuma, former President Mr JG Zuma's younger brother;
- Dr Baldwin Sipho "Ben" Ngubane, a medical doctor and an astute politician who held multiple positions in the Provincial and National Government.

Dr Ngubane served on the Board of the SABC and was also the Chairperson of the Land Bank, among other roles.

Prior to joining Eskom, Dr Ngubane was South Africa's Ambassador to Japan. He was awarded the Grand Cordon of the Japanese Order of the Rising Sun for his contributions "to the enhancement of the relationship and the co-operation in science and technology between Japan and South Africa".

Dr Ngubane served as the Minister of Arts, Culture, Science and Technology in the national government, Premier of KwaZulu-Natal and Minister of Health in the KwaZulu government.

He served on the Codesa working group which dealt with constitutional principles and constitution making on behalf of the Inkatha Freedom Party.

# 3.1 ANNOUNCEMENT BY THE SPEAKER REGARDING AN EXECUTIVE STATEMENT BY THE PREMIER

Honourable Members, before we proceed, it is imperative that I make an announcement on a matter that is on the Order Paper for today.

The Premier has written to the Speaker, requesting that he be allowed to make an executive statement to this House, in terms of Rule 104, on recent incidents in the province. Due to the gravity and extent of these incidents, it is imperative that we as a Legislature deal with it extensively

and comprehensively and are provided with all of the necessary information relating to the efforts of the Executive Council to address the situation.

We know that Rule 104 imposes a time limit of 20 minutes on the Premier to make a statement, except if the Presiding Officer consents to a longer time allocation. Due to the gravity of the incidents of the past few days, it is my considered opinion that a 20-minute time limit may not be adequate to allow the Premier to give a comprehensive report to the House, and that sufficient time should be given to the Premier to enable him to ventilate the matter properly.

In light of this, and in light of the provision of Rule 104(2) which empowers the Speaker to consent that the Premier may exceed 20 minutes in making his executive statement, I hereby wish to advise that I have given consent that the Premier may exceed the 20-minute time allocation to make his executive statement, should this be necessary.

I trust that the above is in order.

### 3.2 RULING ON VIRTUAL SITTING AND VOTING

Honourable Members are reminded that this Virtual Sitting will be conducted in terms of the Rules for Virtual Meetings, read with our existing Standing Rules.

In terms of Rule 6 of the Rules for Virtual Meetings, the quorum requirement for Virtual Sittings of the House is as provided for in the Constitution of the Republic of South Africa and the Standing Rules of the Legislature. Standing Rule 44 of the Standing Rules provides that —

<sup>&</sup>quot;at least one third of all the members of the Legislature must be present to constitute a plenary meeting of the Legislature."

Rule 44(2) further states that a majority of the Members of the Legislature must be present before a vote may be taken on a Bill.

The Rules for virtual meetings also define "present" as follows:

"present" means the attendance of a Member in a virtual meeting by electronic means in a manner that allows the Member to join and participate in the meeting.
