- **3.1** I wish to inform Members of the passing on of the following persons, i.e.:
  - Mr Ebrahim Ebrahim, anti-apartheid activist, struggle veteran and former Deputy Minister of International Relations and Co-operation. Ebrahim joined Umkhonto we Sizwe in the early 1960s. He was convicted of sabotage several years later and sent to Robben Island to serve a 15-year sentence. He served as Deputy Minister of International Relations and Co-operation from 2009 to 2014; and
  - Ms Lindiwe Mabuza, a South African High Commissioner to the United Kingdom, politician, diplomat, poet, academic, journalist, and cultural activist. She was an anti-Apartheid activist. She served her country as a Member of the first democratically elected Parliament of South Africa.
  - All victims of gender-based violence and hate crimes;
  - All victims of road fatalities in our province during the recent past; and
  - All South Africans who have recently passed away as a result of Covid 19-related complications.

These persons may no longer walk among us, but their memory will forever live on in our hearts and minds.

Honourable Members, let us observe a moment of silence in honour of all these departed souls.

May their souls rest in peace.

Rule 49(1) of the Standing Rules provides that –

Rule 49(2) further states that -

- (a) a majority of the members of the Legislature must be present before a vote may be taken on a Bill or an amendment to a Bill;
- (b) at least one third of the members must be present before a vote may be taken on any other question before the legislature; and
- (c) all questions are decided by a majority of the votes cast.

The Standing Rules also define "present" as follows:

"present" in relation to virtual sittings or meetings, means the attendance of a member in a sitting or meeting held through electronic means in a manner that allows the member to join and participate in the meeting.
