Honourable Members, thank you for joining this Virtual Special Sitting that has been called for today.

The Sitting is intended to fill the vacancy that came about after the resignation of one of our Permanent NCOP Delegates, Honourable Mr Xolani Ngwezi.

According to the KwaZulu-Natal Legislature Standing Rules, Standing Rules 252 and 253 respectively, the appointment of NCOP Permanent Delegates must be by way of resolution of the House. The appointment of Permanent Delegates is in accordance with the Determination of Delegates (National Council of Provinces) Act No. 69 of 1998.

I trust that this is in order.

2.2 ANNOUNCEMENT ON VIRTUAL SITTING AND VOTING

Honourable Members are reminded that this Virtual Sitting will be conducted in terms of our amended Standing Rules.

Rule 49(1) of the Standing Rules provides that —

"at least one third of all the members of the Legislature must
be present to constitute a plenary meeting of the Legislature."

Rule 49(2) further states that-

- (a) a majority of the members of the Legislature must be present before a vote may be taken on a Bill or an amendment to a Bill;
- (b) at least one third of the members must be present before a vote may be taken on any other question before the legislature; and

(c) all questions are decided by a majority of the votes cast.

The Standing Rules also define "present" as follows:

"present" in relation to virtual sittings or meetings,
means the attendance of a member in a sitting or
meeting held through electronic means in a manner that
allows the member to join and participate in the
meeting;

I am satisfied that we have the necessary quorum present

Party voting

Rule 288(4) of the Rules also states that -

"The presiding officer or chairperson must, before or at the start of the discussion on the matter, expressly inform members if a party vote will be taken."

In line with the above, I confirm that-

1. the matter of the appointment of the IFP permanent delegate to the NCOP will be done on a party-by-party basis.

A party vote is a collective vote on behalf of all the members of a party present at this Virtual Sitting, up to the total membership of that party in the sitting. I will, however, allow an opportunity for any individual

Member to vote differently from his/her party, or to abstain, if
any Member wishes to do so.
