"present" means the attendance of a Member in a virtual meeting by electronic means in a manner that allows the Member to join and participate in the meeting.

The Secretary has confirmed that we have the required one-third of Members present in order to commence with the Virtual Sitting. The Sitting is therefore properly constituted.

Rule 7(d) of the Rules for Virtual Sittings also state that-

"The presiding officer must, <u>before or at the start of the</u> <u>discussion on the matter</u>, <u>expressly inform Members</u> if a party vote will be taken."
