2.1 Mr Billy Masetlha, South Africa's ambassador to Algeria and a former National Intelligence Agency (NIA) directorgeneral. He served as a senior ANC leader and had been elected to the party's national executive committee several times. Mr Masetlha played a pivotal role in *Umkhonto weSizwe*. He went into exile in the late 1970s and lived in Botswana and Zambia. He was the founding member of the Congress of South African Students and participated in various political organisations, including the Azanian Students Organisation and the Soweto Students Representatives Council.

- 2.2 Mr Charles Ngazi Tembe, the brother of the Deputy Speaker, hon R T Mthembu;
- 2.3 Mr Thembinkosi Apleni, EFF Member of Parliament. Mr Apleni had a passion for the youth and contributed immensely to curbing youth unemployment and improving the conditions of the indigent in South Africa;
