MINUTES OF PROCEEDINGS

Thursday, 31 August 2023

The Hybrid House met at 09h07.

- 1. 09h08 Members were given an opportunity for silent prayers or meditation.
- 2. O9h10 The Deputy Speaker made announcements, including the passing away of the following persons:
 - 2.1 Mr ET Vezi, a former member of the Legislature who also served as the Chief Whip of the Majority Party in the Legislature between 1994 and 2004. Mr Vezi was laid to rest in Harding last month;

- 2.2 Mr Mlondi Mkhize, brother of the honourable Ms PP Harricks, who was laid to rest on Saturday, 12 August 2023;
- 2.3 Mr Jabulani Thamsanga Zama, a prominent businessman and founder of the popular Eyadini Lounge in Umlazi. Mr Zama was a visionary entrepreneur who had built а entertainment hub that helped put Umlazi on the global map. His popular shisanyama has given upcoming artists a platform to showcase their talents. The venue has also been a source of employment for hundreds of youths in Umlazi Township who work there in various capacities. Mr Zama became a role model for upcoming entrepreneurs who emulated his visionary business skills:
- 2.4 Mr Johaar Mosaval, legendary South African ballet dancer. Mr Mosaval was the first black South African to become a senior principal dancer at The Royal Ballet based in London. In March 2019, he received the Order of Ikhamanga in Gold, awarded by President Cyril Ramaphosa;
- 2.5 Ms Monica Sophie Xulu (aged 70) and Ms Zanele Mbuso (aged 60) who were reported missing on 9 August 2023 from eThembeni crèche in uMgababa where they had worked. On Friday, 18 August 2023, the Search and Rescue K9 Unit of the SA Police Service found the two buried in a shallow grave next to the daycare centre where they had been employed, with their hands tied and plastic bags over their heads;
- 2.6 Msunduzi Municipality Councillor Mabhungu Mkhize who passed away on Friday, 25 August 2023 after being gunned down in Imbali Unit 14, Pietermaritzburg, mere hours after holding community prayers for peace in that area;

- 2.7 At least 47 people who perished after a fire broke out in a building in the Johannesburg CBD in the early hours of this morning. It is expected that the number of fatalities may still increase as many more people have been seriously injured in the fire:
- **2.8** All victims of gender-based violence, femicide and hate crimes;
- 2.9 All public servants and traditional leaders in KwaZulu-Natal and the country at large; and
- **2.10** All victims of road fatalities in our province during the recent past.

- 6. 09h36 Mr SM Sonjica, ANC, delivered the following Member's Statement and concluded at 09h37:

The African National Congress in the KwaZulu-Natal Legislature applauds the Department of Education for the recently announced Learner Transport Programme budget adjustment of R263 837 873 to the department's budget for the financial year 2023/24 to guarantee that our learners have practical, dependable and secure access to schools in response to the difficulties that they faced

and which impacted 74 000 beneficiaries who rely on this funded programme.

We also appreciate Treasury's assistance in helping the Department of Education as Treasury saw the urgency, importance and necessity for this change. The Learner Transport Programme remains an essential component in addressing the educational disparities regarding access that our learners confront. Undoubtedly, this liberation movement is having d an impact on the lives of our learners, demonstrating the ANC-led government's apparent influence.

It is indeed encouraging that such progressive agreements were reached. They must also empower the youth and all women, especially in deep rural areas. Indeed, the provincial government has demonstrated that women's empowerment is indeed a priority. Forward with women empowerment, forward! Vote ANC in 2024.

9. 09h39 Mr OB Kunene, IFP, delivered the following Member's Statement and concluded at 09h40:

A few months ago, the Department of Co-operative Governance and Traditional Affairs (Cogta) announced that eThekwini Metro had been placed under section 154 intervention. Dr Cassius Lubisi, former Director-General in the Presidency, was announced as the convenor of a team of experts which included Dr Mike Sutcliffe, former eThekwini City Manager and now local government consultant. Thandeka Ellenson was also meant to be introduced.

The IFP and the public are keen to know whether the section 154 intervention at eThekwini, led by Dr Cassius Lubisi, has commenced. It is incumbent upon the KZN MEC for Cogta, hon Bongi Sithole-Moloi, to inform the public of the department's progress on this matter as eThekwini Metro is a shamble and in dire need of competent leadership.

10. 09h42 Mr S Bhanprakash, IFP, delivered the following Member's Statement and concluded at 09h43:

Many coastal towns in KwaZulu-Natal continue to be plagued by the aftermath of the April 2022 floods. Damage to sewer pipelines and effluent spillage into our

rivers perpetuate the damage done to our sensitive estuarine ecosystems.

There appears to be a lack of urgency by the respective authorities to resolve infrastructural damage. In turn, this type of pollution has had a serious negative effect on our tourism industry for which our province was previously renowned. Moreover, tourism in KZN is a significant part of the economic development of the province.

Also, we continue to expose our communities to waterborne diseases and associated health risks. There needs to be more urgent and co-ordinated efforts on the part of the respective departments to resolve outstanding infrastructural and environmental issues.

11. 09h43 Dr I Keeka, DA, delivered the following Member's Statement and concluded at 09h44:

That 20 educators at Woodlands Secondary can abandon their duties and trek to court in support of their alleged sex pest principal is shocking. That there are no consequences is even worse!

There are deep-seated issues at that school and matters raised by the SGB are being ignored. Governance and relations are at an all-time low, to the extent that the SGB is locked out of the school. The department allegedly wants to disband the SGB instead of dealing with the issues and the chaos.

Last week, a 10-year-old boy in Ixopo was mauled by a dog on the school's premises, and department officials responded by saying, "These things happen." No, they do not just happen, and the MEC must know that the buck stops with her! Where is the accountability?

The MEC and her department must not sit on these matters with a malicious attitude and these words: "Let them eat cake!" This is intolerable.

The MEC, as the executive authority of the department, has the opportunity to tell us what she is going to do about these matters.

We require a synthesised approach intersecting city, sustainable and technology development, using back-casting to develop action plans from a shared vision of stakeholders who have participated in recent summits.
