3.6 MEMBERS ATTENDANCE

Members are reminded that their attendance at Sittings and committee meetings is regulated by the Standing Rules. In this regard Rule 28(2) provides that a member's leave of absence from the Legislature during a session, must be approved by the member's party.

However, Rule 29 further provides that the period for which leave may be granted by the member's party, other than maternity leave and parental/ adoption leave as provided for in Schedule 2 to the Rules, may not exceed 3 consecutive sitting days in a session.

In terms of Rule 29(2), any leave of absence in excess of 3 consecutive sitting days may be requested of the House by motion, which must be requested "not later than by the close of the third consecutive sitting day of the member's absence."

Rule 30(1) further provides that any member who absents himself or herself for 3 or more consecutive sitting days without authorisation as provided for in these Rules, loses his or her membership of the Legislature in accordance with section 106(3)(b) of the Constitution.

In line with the above, members are advised that legislature records reflect that there are some members who are at risk of being found to be in transgression of Rule 30(1);

All members are therefore urged to ensure that they comply with the relevant Rules pertaining to attendance.

3.7 DELAY IN SUBMISSION OF THE CONSOLIDATED STATEMENTS AND THE AUDITOR GENERAL'S AUDIT REPORT FOR THE 2022/23 FINANCIAL YEAR

Honourable members, the KwaZulu-Natal Provincial Legislature has been notified by the Provincial Treasury, in terms of section 19(5) of the Public Finance Management Act (PFMA), of the failure by the Provincial Treasury to submit the Consolidated Financial Statements and the Auditor General's Audit Report to the Provincial Legislature within seven months of the financial year-end, and the reasons for that.

The final audited financial statements were signed by the Auditor-General on:

- 22 August 2023 for public entities; and
- 31 July 2023 for departments.

It is at this stage a reliable set of consolidated financial statements that can be prepared for submission to the Auditor General for audit by 31 October 2023. In view of this, it is anticipated that the audited consolidated financial

statements will be submitted for tabling by 29 February 2024.
