2. OBITUARIES AND OTHER CEREMONIAL MATTERS (Item 2 on the Order Paper)

Honourable Members, let us take a moment to remember in our thoughts and prayers all those souls who have departed from us since our last sitting, either due to natural causes or otherwise. They are:

2.1 Mr Pravin Jamnadas Gordhan, former Commissioner of the South African Revenue Service from 1999 to 2009. Between 1991 and 1994 he chaired the Convention for a Democratic South Africa (Codesa) and was the co-chairperson of the Transitional Executive Council which prepared South Africa for its first non-racial election in April 1994.

Mr Gordhan was an anti-apartheid activist who held various ministerial posts in Cabinet. He served as Minister of Finance from 2009 until 2014, and again from 2015 until 2017. He also served as Minister of Co-operative Governance and Traditional Affairs from 2014 until 2015 and as Minister of Public Enterprises from February 2018 until June 2024.

2.2 Dr Tito Titus Mboweni, ANC stalwart, first Minister of Labour in South Africa's first democratic Parliament from 1994 to 1999 under former President Nelson Mandela, former Minister of Finance and first black Governor of the South African Reserve Bank. Dr Mboweni was a dedicated public servant who played a crucial role in shaping the country's economic policies.

He was a founding member of Mboweni Brothers Investment Holdings and a former international advisor of Goldman Sachs International. He was also appointed to the position of non-executive Director for South Africa at the New BRICS Development Bank.

Dr Tito Titus Mboweni was known for his sharp intellect, infectious humour and outspoken nature, often engaging in lively debates on social media where he had amassed a large following;

2.3 Mr Membathisi Mphumzi Shepherd Mdladlana, former Minister of Labour from July 1998 to 2009. Whilst in Parliament, Mr Mdladlana served as Chairperson of the Constitutional Assembly Committee (Theme Committee

Four) from 1994 to 1996; as a member of the Portfolio Committee on Home Affairs from 1994 to 1998, and as a Whip of the Parliamentary Programming Committee from 1995 to 1998.

He also served as Deputy Chairperson of the Parliamentary Scout Union of South Africa from 1996, and as a member of the Portfolio Committee on Education at National Parliament between 1994 and 1998:

- 2.4 Her Royal Highness Princess Sibuyiselwe Angela Buthelezi, the youngest child of the late uMntwana waKwaPhindangene, Prince Mangosuthu Buthelezi, and the late Undlunkulu Princess Irene Audrey Thandekile Buthelezi. Princess Sibuyiselwe Angela Buthelezi was an IFP member of the National Assembly, a member of the Portfolio Committee on Human Settlements and an alternate member of the Portfolio Committee on Tourism;
- 2.5 Mr Zenzele Ndlela, former Senior Manager: Supply Chain Management in the KwaZulu-Natal Legislature;
- **2.6** Mrs Ntombifikile Florence Ntozakhe, mother of Mr Themba Ntozakhe, an administrator at KwaZulu-Natal's NCOP Offices;
- 2.7 Mrs Nomfundo Shazi, wife of Mr Sanele Shazi from the Legislature's ICT Unit;
- 2.8 Mrs Siziwe D Shelembe, mother of Mr Thulani Mhlanga from the Legislature's ICT Unit;
- **2.9** Pastor Ray McCauley, an evangelic leader and founder of the Rhema Bible Church:

- 2.10 Mr William Smith, South Africa's most treasured television teacher, who spent his whole life pioneering work in education and transforming the learning of mathematics and science for countless students;
- **2.11** Ms Thabiso Sikwane, radio and television personality who worked for *SAFM*, *KayaFA*, *YFM* and *Voice of Soweto*, *inter alia*:
- **2.12** Bishop Jessica Mbangeni, praise poet, spiritual leader and cultural ambassador;
- 2.13 Mr Sandile Ngwenya, a kwaito legend popularly known as "Mapaputsi". He was well known for his 2001 album with songs such as Woza Friday, Manga Manga Business, My Love, and his culture-shifting hit song Izinja which earned him the award for Best Kwaito Song at the Metro FM Awards ceremony in 2002;
- 2.14 Mr Solomon Molokoane, legendary gospel artist who was popularly known as Solly Moholo. Solly Moholo was hospitalised after falling ill following his pre-album launch tour in Botswana. He rose to fame in the early 2000s with an endearing sound, look and dance style that had been inspired by the Mokhukhu singers associated with the Zion Christian Church;
- **2.15** Five family members, including two children, who were stabbed to death by a relative in Bergville;
- 2.16 Five people who died in a head-on collision on the R102 near Darnall in Ilembe District Municipality;
- 2.17 Three people who died in a two-vehicle collision along the N2 near Fairbreeze Mine and Gingindlovu *en route* to Richards Bay;

- 2.18 Seven members of the Khabule family, including three children, who were brutally murdered in the Hlokozi area near Highflats in Sisonke District Municipality;
- 2.19 Three members of the Nzama family in Ezinqoleni in Ray Nkonyeni Municipality who were burnt to death when their house caught fire;
- 2.20 Ms Hlengiwe Sikhosana (23) in Ward 2, Jijintaba under KwaMbotho Tribal Authority who was brutally murdered this week by her partner who has now been arrested.
- **2.21** Eight people who died in a collision involving a truck and a vehicle in Mandeni:
- **2.22** All victims of gender-based violence, femicide and hate crimes;
- 2.23 Public servants and traditional leaders of this province and the country at large who have passed away; and
- **2.24** Various victims of road accidents, as mentioned above, and others who have lost their lives in our province during recent times.

Let us now please observe a moment of silence in honour of the memory of all those who have gone before us.
