Party voting

Rule 288(4) of the Rules states that -

The presiding officer or chairperson must, before or at the start of the discussion on the matter, expressly inform members if a party vote will be taken.

In line with the above, I can confirm that voting will take place on the -

Conferral of Final Mandates on the Division of Revenue Bill [B4-2024] and the Basic Education Laws Amendment Bill [B2D-2022].

Bear in mind that a party vote is a collective vote on behalf of all the Members of a party present at a virtual sitting, up to the total membership of that party in the sitting.

I will, however, allow an opportunity for any individual Member to vote differently from his/her party, or to abstain, if any Member wishes to do so.

- **2.3.1** Among those who have recently departed is Inkosi BN Mdletshe, former Speaker of the KwaZulu-Natal Legislature. Inkosi Mdletshe was part of our institution between 1994 and 2013. A lawyer by training and a traditional leader in Umkhanyakude District, Inkosi Mdletshe served the Legislature in various capacities. He was a member of several portfolio committees such as Health, Conservation, the Premier and Roval Household, inter alia. Inkosi Mdletshe was the Speaker between 1998 and 2004 and retired from the through Fourth Legislature midway the Administration:
- **2.3.2** Mr Sikhumbuzo Gumede, Deputy Director General at the Department of Co-operative Governance and Traditional Affairs;
- **2.3.3** Mr Dingaan "The Rose of Soweto" Thobela, a former three-time world boxing champion. Mr Dingaan

Thobela held three world titles in two weight divisions, the WBO and WBA lightweight titles as well as the WBC Super Middleweight title which he won in 2000;

- **2.3.4** All victims of gender-based violence, femicide and hate crimes;
- **2.3.5** All public servants and traditional leaders of this province and the country at large; and
- **2.3.6** All victims of road fatalities in our province during the recent past.

Let us now observe a moment of silence to honour all those who have gone before us.
