Tuesday, 14 May 2024

The Virtual House met at 08h30.

- 1. 08h31 Members were given an opportunity for silent prayers or meditation.
- 2. 08h32 The Speaker made announcements, including the passing away of the following persons:
 - 2.1 Justice Yvonne Mokgoro, former Constitutional Court Judge, who was involved in a serious car accident near Kimberley in April 2023. Her injuries led to further health setbacks while she was in hospital. Justice Mokgoro was a member of the first Constitutional Court Bench and its first black female judge. After her retirement from the Bench

in 2009, she continued to play an important role in legal and civil society circles. She chaired the SA Law Reform Commission and served on the Bench in both Lesotho and Namibia. She was a member of the International Council of Arbitration for Sport, chaired the United Nations Internal Justice Council, and took on the significant responsibility of Chairperson of the International Expert Mechanism to Advance Racial Justice and Equality in Law.

In addition to these professional contributions, Justice Mokgoro devoted much time and energy to nurturing the next generation of lawyers and leaders, both as a board member of the Mandela-Rhodes Trust and through her involvement in teaching around the world.
